

Limited Lifetime Warranty

Foundations warrants that all hardware on Retail Wood Changing Tables will provide a lifetime of reliable use when the Retail Wood Changing Table is assembled, maintained, and used in accordance with our instructions. This lifetime warranty remains in effect throughout the useful life of the product.

Foundations warrants that all non-hardware components of the Retail Wood Changing Tables will provide two years of reliable use when the product is assembled, maintained, and used in accordance with our instructions. The pad that accompanies the Retail Wood Changing Table is warranted for six months. Warranty coverage terminates if you sell or otherwise transfer ownership of the Retail Wood Changing Table.

Foundations does not warrant any Retail Wood Changing Table that has been used for purposes other than its intended use, altered, misused, abused, or not properly maintained. Foundations does not warrant against scratches, dents, or other cosmetic damages that are caused by normal use or wear and tear. If the Retail Wood Changing Table has been damaged or altered immediately stop using the Retail Wood Changing Table and contact Foundations to determine if the Retail Wood Changing Table is safe for use. If the Retail Wood Changing Table is not safe for use, please destroy or discard the Retail Wood Changing Table so that it may not be used again.

If the Retail Wood Changing Table is defective in any way, please contact us at 877-716-2757. Contact Foundations ONLY with any and all warranty claims, and DO NOT contact the retailer, dealer, or distributor where the product was purchased. When you call, have available the model number, the date of manufacture that can be found on the Retail Wood Changing Table, and the date of purchase. Please do not contact the distributor or retailer as they are not authorized to resolve the issue. If the Retail Wood Changing Table is defective Foundations, in its discretion, may replace, repair or give a full or partial credit towards new merchandise. Foundations may require the defective Retail Wood Changing Table to be returned prior to its replacement or a credit given. Only if Foundations determines that the Retail Wood Changing Table is defective will Foundations refund the cost of shipping the Retail Wood Changing Table to Foundations. This warranty gives you specific legal rights and you may also have other rights which vary state to state.
